CALL TO ORDER

APPROVAL OF MINUTES

ITEMS FOR CONSIDERATION

CPS09/06 - 34 It was moved by Engle, supported by Mahoney, to approve the hiring freeze be waived to fill District Court Clerk position #D15017, through the current posting procedures as set forth in the Teamsters Local 214 labor contract. *MOTION CARRIED.*

CPS09/06 - 35 It was moved by Engle, supported by Snider, to waive the hiring freeze to fill the vacant Clerk II position #G200019, posting with current union employees. - CPS09/06 - 37 It was moved by Nash, supported by Engle, to grant permission to purchase from Seer Corporation 20 helmets for the Posse, to be reimbursed in total by the Posse. *MOTION CARRIED.*
- CPS09/06 - 38 It was moved by Engle, supported by Mahoney, to allow the Sheriff to fill the open position for Corrections Officer position #O10006. *MOTION CARRIED.*
- CPS09/06 - 39 It was moved by Wade, supported by Engle, to waive the hiring freeze and allow the Sheriff's Office to fill the vacant Sheriff Finance Supervisor position (X84801), transfer the current incumbent of the Info Systems Tech III position (X43906) into the Sheriff Finance Supervisor position, then reclassify the Info Systems Tech III position (X43906) to a Microcomputer Analyst position and waive the hiring freeze and allow the Sheriff's Office to fill the newly reclassified Microcomputer Analyst position. *MOTION CARRIED.*
