



Honorable Commissioners:

As requested by the County Board of Commissioners, the Muskegon County Equalization Department has prepared this tax abatement report which contains the valuations of tax-abated property for each unit of government in a tabular format. It is the result of a collaborative effort involving all 23 assessing jurisdictions in Muskegon County. The amounts reported by these jurisdictions have been examined and internally audited. The report focuses on the value of all real and personal property subject to Industrial Facility Tax (PA 198 of 1974, as amended). Obsolete Property as well as Neighborhood Enterprise Certificates and Land Banks, which are also exempt from ad valorem taxation, are presented separately. The report was also revised beginning in 2011 to account for both the New Personal Property Exemption (PA 328 of 1998) and the Commercial Rehabilitation Act (PA 210 of 2005, as amended).

For 2020, the Industrial Facility Tax accounts increased from \$42,002,000 to \$51,852,900 in State Equalized Value (SEV). This indicates an approximate 23% percent increase. The number of active accounts has increased from 151 accounts in 2019 to 164 accounts in 2020.

The value of all expired abatements is transferred to the general ad valorem property tax roll. The abated properties now represent less than 1 percent of the State Equalized Value (SEV) of the general ad valorem properties.

In 2006, there were revisions to Public Act 451 of 1994, the Natural Resources Environmental Protection Act, as amended by Public Act 513 of 2004 that changed the procedures used in the assessment, equalization, and taxation of real property owned by the State and controlled by the Department of Natural Resources (DNR). This Act basically removed the DNR properties from the ad valorem roll and placed them on a specific roll (Act 513 Roll).

Beginning in 2009, the Consumer Price Index factor was applied to DNR properties. Previously, the 2004 taxable valuation (TV) was the basis for the TV of the property from 2004 until 2009 providing no acquisitions or dispositions occurred. P.A. 603 of 2012 resulted in significant changes to the DNR values beginning with the 2013 year and continuing to the present.

All values were subject to review and revision by the Michigan State Tax Commission until October 15th of this year. The taxable value limitation also applies to tax abated properties.

I acknowledge our local assessors' professionalism. This year very few problems were detected during the preparation of this report.


